Our aim is to consolidate our position as a leader in terms of service offered to customers, while contributing to the well-being of the communities we serve, with special attention for the Environment, the Health and Safety and the respect for human rights for Employees and for all those who come into contact with our organization.

For this purpose, the Management has decided to continue along the path taken more than 20 years ago with the first certification according to UNI EN ISO 9002, gradually developing and adapting its Management System to UNI EN ISO 9001:2015, UNI ISO 45001:2018 and SA 8000:2014. The targets were back then and remain nowadays the compliance with the national and European regulations in the field of environmental protection and a strong commitment to ensure compliance with the legislation on occupational health and safety and with all the rules that govern labor relations.

A deep environmental analysis now allows us to constantly monitor all the environmental impacts resulting from our activities. Our Occupational Health and Safety Management System ensures all of our employees and associates carry out their activities under the best safety conditions, and transparency in labor relations with employees and collaborators allows us to go beyond the basic compliance with laws on employment.

SAFETY AND OCCUPATIONAL HEALTH. Therefore, the distribution and use of alcohol in our offices, and in general during working hours is strictly forbidden according to the laws and regulations, as well as the use of drugs and substances that can be addictive.
